CANCELLATION AND REFUND POLICY

Should a student be terminated or cancel for any reason, refunds will be made according to the following schedule:

- 1) Cancellation must be made in person or certified mail.
- 2) All monies will be refunded if the applicant is not accepted by the school or the student cancels within three (3) business days after signing an enrollment agreement and making initial payment.
- 3) Cancellation after the third (3) business day, but before the first class, will result in a refund of all monies paid with the exception of the registration fee.
- 4) Cancellation after attendance has begun, but prior to 40% completion of the program will result in a pro-rated refund computed on the number of class hours completed to the total amount of program hours.
- 5) Cancellation after completing 40% of the program will result in no refund.
- 6) The termination date for refund computation is the last date of the actual class held unless earlier written notice is received.
- 7) Refunds will be made within 30 days of termination or after written notice of cancellation.
- 8) If the institute should cancel a course, students will have the option of a full refund or placement in the next class.

Grounds For Termination
